ATO issues warning about registration issues for backpackers

The Australian Tax Office's (ATO) registration process for employers of working holiday makers is currently not working.

The ATO has apologised for the inconvenience and according to the announcement made on its website this week, the office is working hard to fix the problem as soon as possible and expects the form to be available well before 1 January 2017.

"Registration has been extended to 31 January," the website says.

"If you can't register because of our system issues, and you are employing working holiday makers, you will not be penalised as long as you register by 31 January 2017. You can still use the new withholding tax rate of 15% from 1 January 2017."

From 1 January 2017, the working holiday maker tax rate of 15per cent will apply from the first dollar earned.

Backpackers holding a visa subclass of 417 or 462 will not be able to claim the tax-free-threshold regardless of their residency status and must provide a tax file number (TFN), otherwise, employers will need to withhold at the top rate of tax.

Employers have also been warned not to employ or pay someone for work if they don't have permission to work in Australia.

More than 20 scholarships up for grabs

The nation's Horticulture research and development corporation, Horticulture Innovation Australia (Hort Innovation), today urged growers and people working in the supply chain to apply for one of 22 scholarships to help propel their business to the next level.

Closing on December 31, the Masterclass in Horticultural Business scholarships include 15 for vegetable businesses, three for the nursery industry, and four for general horticulture.

Hort Innovation Chief Executive John Lloyd said the Masterclass in Horticultural Business will arm participants with world-best-practice skills that can immediately be put into practice.

"This scholarship opportunity is ideal for upcoming leaders looking to learn how to apply practices that have proven effective not just in horticulture locally but also overseas," he said.

Delivered with world leading agriculture university, Wageningen in the Netherlands, renowned university Lincoln in New Zealand and key provider, the University of Tasmania, the Masterclass is the first of its kind in Australia.

Offered online with three face-to-face sessions, the Masterclass will run from February 2017 to December 2017, with around eight to 10 hours per week of engagement required.

Key areas of study include:

- Horticultural Management
- People and Culture
- Supply Chain Management and Logistics
- Financial Management and Law
- Horticultural Marketing and Communication
- Global Trends and International Business
- Innovation and Entrepreneurship
- · Business Development and Strategy.

Mr Lloyd said scholarships will be awarded by a selection committee based on the perceived contribution applicants will make to the future of their industry, with a particular focus on innovation.

"Australian horticulture sectors are hugely innovative with a strong appetite for delivering a consistent, quality product for consumers while increasing production efficiencies and ultimately boosting farmgate returns," he said.

"We look forward to seeing some great outcomes from the scholarship participants in this course, and encourage anyone with a drive to take their sector to new heights to apply."

Woolworths case loss raises questions about the ACCC's supermarket strategy

Last week, the Australian Competition and Consumer Commission (ACCC) lost a Federal Court case. It was trying to prove that Woolworths had engaged in "unconscionable conduct". The ACCC had alleged that Woolworths sought to systematically obtain payments from various suppliers in order to reduce a profit shortfall. More

Monsanto shareholders approve Bayer deal

Shareholders of Monsanto Company (NYSE: MON) have given the green light to a US\$66 billion takeover from a German multinational Bayer AG. If regulatory approvals go ahead, the

merger would combine two of the world's largest companies involved in crop protection, crop science and seeds. <u>More</u>

Oxitec's 'self-limiting' GM Medfly ready for open field trials

After a series of successful contained environment studies across various countries, U.K.-based Oxitec is now ready to move to open field trials for its 'self-limiting' Mediterranean fruit fly (Medfly). The studies demonstrated the GM Medfly's ability to successfully mate with others in the wild and subsequently suppress the pest population. The efficacy of the Oxitec Medfly and existing control methods were also examined. More

U.S.-based company Mission Produce says next season will likely be its 'first full avocado harvest' from Peru, coinciding with a push from the industry to diversify supply sources in the wake of the recent Mexican conflict. <u>More</u>

Meanwhile, the country faces an uncertain trade outlook with the United States, if president-elect Donald Trump carries out his threats against Mexican products. More

Avocados promise great things for Colombia's agriculture

Many Colombian products have a great export potential, but avocados stood out this year and are promising great things for the country's agricultural sector. According to Pro Colombia, avocado exports have increased by 266,3% so far this year, from US\$ 7.3 million in 2015 to US\$ 27.1 million up until October 2016. These figures make it the country's second most exported fruit, only after bananas. More
